Criteria for Laboratory Recognition in Delhi

1) Accreditation:

The laboratory seeking for recognition in Delhi ought to have certified to IS/ISO/IEC 17025 or ISO/IEC 17025 within the individual check and will be a member of Asia Pacific Laboratory certified Co-operation (APLAC) and/or International Laboratory certified Co-operation (ILAC).

2) Laboratory:

Â

(a) The laboratory should be maintained and manned by regular, qualified and competent personnel.

Â

(b) The laboratory should follow test facilities as per relevant Indian Standard.

Â

(c) Proper electrical power and water supply facility must be present at the centre.

Â

(d) The Centre must provide declaration in the form of certificate and complete report of the tested material or product.

Â

(f) The laboratory or the test centre must be independent (no link to any organization).

Â

(g) Documentation (Receipt, Sample Processing, & Contract Papers) should be completed and kept in a single place at the time of Audit.

Â

(h) The laboratory has to pay the ethical fees to BIS from time to time.

Â

(i) Auditee Laboratory is bind to pay the travelling and stay expenses of the auditors as per entitlement.

### 3) Testing Charges:

As per Indian Standards, the laboratory testing charges for the relevant test is valid for a period of 3 years. However, in the event of any revision of the Indian Standard or issuance of an amendment to the Indian Standard, the revised testing charges shall be considered and made effective with the prior approval of the Competent Authority.
